

**RESOLUTION NO. 2009-2**

**A RESOLUTION OF THE BOROUGH OF CENTRE HALL, CENTRE COUNTY, PENNSYLVANIA, AUTHORIZING THE EXECUTION OF AN AGREEMENT WITH THE PENNSYLVANIA DEPARTMENT OF TRANSPORTATION, AUTHORIZING THE REIMBURSEMENT AGREEMENT FOR THE SR45 SECTION 135 HIGHWAY AGREEMENT FOR THE RELOCATION OF THE EXISTING WATERMAIN**

**WHEREAS**, the Borough of Centre Hall (Borough) is a municipal corporation organized under the Laws of the Commonwealth of Pennsylvania.

In accordance with the requirements of the Pennsylvania Department of Transportation Design manual – Part 5, chapter 3.2, the Centre Hall borough does hereby authorize the submission of the attached request for the Pennsylvania Department of Transportation to provide a fixed 50 per centum reimbursement to the Centre Hall Borough for all costs incurred in relocation our Water Line located in the public right of way and affected by SR45 Section 135 necessitated by the Pennsylvania Department of Transportation Highway Improvement in Centre County.

Also the Centre Hall Borough Council President of the said Municipality be authorized and directed to sign a utility Reimbursement Agreement on its behalf and that the Centre Hall Borough Secretary be authorized and directed to attest the Centre Hall Borough Council President's signature on the utility Reimbursement Agreement for this highway project.

**NOW, THEREFORE**, be it resolved and it is hereby resolved by authority of the same as follows:

1. Centre Hall Borough Council hereby approves the expenditure of a fixed 50 per centum for all costs incurred in relocation of our Water Line located in the public right of way and affected by SR45 Section 135 necessitated by the Pennsylvania Department of Transportation Highway Improvement in Centre County, provided the Pennsylvania Department of Transportation will pay or reimburse Centre Hall Borough the remainder 50% of the costs.
2. That all prior Resolutions or Ordinances, or parts thereof inconsistent herewith are hereby repealed.
